**Disclosure of Technical Evaluation**

After Preliminary and Detailed Technical Evaluation, based on the provisions of Clause 5.3 and 5.4 of ITB respectively, the Evaluation Committee has concluded that:

1. M/s LCESPL substantially fulfils the requirements as per the clauses of bid document and hence, this bid is responsive for opening of Part II.
2. M/s IHPCL substantially fulfils the requirements as per the clauses of bid document and hence, this bid is responsive for opening of Part II.
3. M/s Vishvaraj Infrastructure Limited-Central India Engineering (VIL-CIE JV) does not fulfill the criteria set out under clause 1.4(D)(a) read with corrigendum 5 and 1.5. Hence, M/s Vishvaraj Infrastructure Limited-Central India Engineering (VIL-CIE JV) does not qualify for opening of Part II.
4. M/s TPPL substantially fulfils the requirements as per the clauses of bid document and hence, this bid is responsive for opening of Part II.
5. M/s SMC IPL substantially fulfils the requirements as per the clauses of bid document and hence, this bid is responsive for opening of Part II.
6. M/s TCEL-HCL JV substantially fulfils the requirements as per the clauses of bid document and hence, this bid is responsive for opening of Part II.
7. M/s JMC- Ramky (JV) substantially complies with all the requirements as per the clauses of bid document and hence, this bid is responsive for opening of Part II.

As per the conditions laid down in Section 5 clause 5.1(6), the above conclusions are being disclosed on the websites mpudc.co.in and mpeproc.gov.in. As per clause 3.2.4 of ITB, bidders at Serial No. 1, 2, 4, 5, 6 and 7 are required to submit the original documents except financial quote on or before 2 PM on 22<sup>nd</sup> February 2017.
