The technical bids for package 1 (stated above) under KfW funded MPUSEP were opened on 7th August 2018. Bids from four bidders as under were received:

1. JITF Water Infrastructure Limited + SPML, New Delhi (JV)
2. Kalthia Engineering and construction ltd + Miral Infrastructure, Ahmedabad(Gujarat) (JV)
3. Jayantisuper Construction Pvt. Ltd, Mehsana Gujarat
4. Tahal Consulting Engineers Ltd, Gurugram

After Preliminary and Detailed Technical Evaluation pursuant to clause 5.3 and 5.4 of Instructions to Bidders, the Bid Evaluation Committee has concluded that **all the four bidders namely 1- JITF Water Infrastructure Limited- SPML, New Delhi (JV), 2- Kalthia Engineering & Construction Ltd - Miral Infrastructure, Ahmedabad (JV), 3- Jayantisuper Construction Pvt. Ltd, Mehsana Gujarat and, 4- Tahal Consulting Engineers Ltd, are substantially compliant with the ITB requirement and hence, all the four bidders are eligible for the next stage of the bid process, i.e., Opening of Financial Bid.**

As per the clause 5.1(6) of Instructions to Bidders (ITB), the above conclusions are being disclosed on the website of www.mpeproc.gov.in and www.mpudc.co.in. The disclosure is also being sent for publication on GTAI. As per clause 3.24 of ITB, the bidders who have qualified for opening of financial bid, are required to submit the original documents except the financial quote, for verification on or before 2 PM on 20th August 2018. The financial bids of the bidders qualified for opening of Part II, will be opened at 04:00 PM on 20th August 2018 at the office of MPUDC - MP Rajya Krishi and Gramin Sahkari Bank, 8 Jail Road, Arera Hills, Bhopal, Madhya Pradesh 462011.
